CERTIFICATION AND RESOLUTIONS OF PUBLIC ENTITY

CERTIFICATION. The undersigned, being the duly elected/appointed and incumbent _____ of _____, a public entity with a Federal Employer I.D. Number _____ and an address at _____ (the "Public Entity") hereby certifies to the BankCard Center with an address at 111 East Miller St, Jefferson City, MO 65101, (the "BankCard Center") as follows:

The Public Entity's Existence. The Public Entity is, and at all times shall be, duly organized and validly existing under the laws of the State of Missouri. The Public Entity has the full power and authority to enter into and perform any and all agreements incidental to the bank card services provided to the Public Entity by BankCard Center.

Notices to BankCard Center. The Public Entity will promptly notify BankCard Center in writing at P. O. Box 779, Jefferson City, Missouri 65102 (or such other addresses as BankCard Center may designate from time to time) prior to any (a) change in the Public Entity's name; (b) modification or rescission of the resolutions below; or (c) change in any other aspect of the Public Entity that directly or indirectly relates to any agreements between the Public Entity and BankCard Center.

RESOLUTIONS ADOPTED. At a meeting duly called and held on _____, 20____, at which a quorum was present and voting, or by other authorized action in lieu of a meeting, the following resolutions were adopted and have not been rescinded or modified:

It Is Hereby Resolved That:

1. BankCard Center is designated as the Public Entity's provider of bank card services subject to such terms, conditions, rules and regulations of BankCard Center governing bank card services from time to time, and the Public Entity's agreement with such terms, conditions, rules and regulations shall be conclusively presumed by the Public Entity's use of the bank card services;
2. All acts and things done prior to the date hereof by or on behalf of the Public Entity in connection with the bank card services are hereby ratified, confirmed, and approved;
3. Any and all prior resolutions adopted by the Public Entity concerning the bank card services continue in full force and effect as supplemented or modified herein.
4. The Public Entity, as any of the persons named below (the "Authorized Representatives") shall deem necessary or desirable, shall enter into and deliver such instruments, documents, agreements, and other writings as in the opinion of the Authorized Representative may be necessary or desirable to obtain the bank card services (the "BankCard Documents"). Each of the Authorized Representatives are hereby authorized and directed (individually and without the joinder of any other Authorized Representative) to enter into and deliver on behalf of the Public Entity, as the Authorized Representative may deem necessary or desirable, any and all of the BankCard Documents

contemplated by these Resolutions, each BankCard Document to be in form and content satisfactory to the Authorized Representative(s), such satisfaction to be conclusively evidenced by the Authorized Representative's execution of the same, and to do all such acts and things as in the opinion of the Authorized Representatives may be necessary or desirable in connection with the bank card services.
